## Startups are the future engines of the country's economy and society: Prime Minister Modi

**Startups now need to focus on the manufacturing sector and create products that meet global standards: Modi**

Prime Minister Narendra Modi said on Friday that startups in India now need to focus more on the manufacturing sector. He said that we need to create new and world-class quality products. On the occasion of National Startup Day, Prime Minister Modi participated in a program at Bharat Mandapam today, marking a decade of the Startup India initiative. The Prime Minister said that earlier, only children from wealthy families started new businesses and ventures, while most children from middle-class and poor families only dreamt of getting a job. But the Startup India program has changed this mindset, and because of this, today young people are solving real problems through startups. The Prime Minister

interacted with members of the startup ecosystem during the program. Some selected startup representatives shared their entrepreneurial journey experiences. The Prime Minister addressed the gathering on this occasion. Calling the continuously increasing role of women in new startups a matter of pride, the Prime Minister said that today, 45 percent of new startups have a woman as a director or partner. India has become the world's second-largest

startup ecosystem in terms of women's participation. The Prime Minister termed the country's startup mission a "Rainbow Mission," saying that it has connected diverse sectors and created new opportunities. He praised the risk-taking ability of the country's youth, saying that today, those who think beyond a monthly salary are not only accepted but also respected. Earlier, risky ideas were viewed as fringe or unconventional, but now they are becoming fashionable.

## Government to introduce strict new bill on seed quality: Shivraj

The central government is going to introduce a bill to ensure better quality seeds for farmers, which includes stringent provisions. Agriculture Minister Shivraj Singh Chouhan gave this information in a media interaction on Friday. Speaking to the media at his residence, the Agriculture Minister said that the penalty provisions in the old 1966 Seeds Act are quite weak. A strong law was needed to protect farmers from substandard and counterfeit seeds and to severely punish those who deliberately sell them. We want to ensure that farmers get good quality seeds. Shivraj said that strict action will be taken against dealers selling counterfeit or poor quality seeds, and they will also have to pay higher fines than before. He said, "Our goal is to ensure that farmers

with selling substandard seeds to farmers. According to the new proposal, deliberate fraud will be met with heavy fines and strict penalties. The minister clarified that the new rules will only apply to commercial companies. Farmers will have complete freedom regarding the exchange of traditional seeds. Farmers can sow their own seeds. The exchange of seeds among themselves or the local exchange of seeds (such as the practice of returning one and a quarter times the amount) will continue. These rules will not affect the rights of small and traditional farmers. He explained that the new system will ensure a complete traceability system for the origin and supply chain of seeds. Through QR codes, it will be possible to track where the seed was produced, who manufactured it, and how it reached the farmer.

**Amidst Tensions, Iran Aims Missiles at Israel; Indian Embassy Issues Advisory**



**Jerusalem:** The ongoing tension between Iran, the US, and Israel has taken a mysterious turn. On one hand, Gulf countries have refused to grant the US airspace for an attack on Iran, while on the other hand, Trump has softened his stance. Following this, Iran has aimed missiles at eight Israeli targets. Amidst all this, the Indian Embassy has recently issued an advisory for its citizens. Indian citizens have been advised to be "extremely vigilant" and to avoid traveling to Israel. In the advisory, the Indian Embassy has conveyed the following message to Indian citizens: "In view of the prevailing situation in the region, all Indian citizens residing in Israel are advised to remain vigilant and strictly adhere to the security guidelines and protocols issued by the Israeli authorities and the Home Front Command." It further states that "Indian citizens are advised to avoid all non-essential travel to Israel."

**Large number of armed men enter Balochistan, vandalize government and private banks**



**Islamabad:** The situation in Kharan district of Pakistan's Balochistan province spiraled out of control when a large number of armed men entered the city and launched attacks in different areas. A media report said that, according to local authorities, the attackers targeted the main police station in Kharan city and vandalized government and private banks. Eyewitnesses said the attackers were riding in cars and on motorcycles. A senior police officer said that no police officer was injured in the attack, but police vehicles and weapons were damaged. The attackers took some weapons with them. According to the police, the attackers entered the police station and forcibly freed the undertrial prisoners who were being held there. After this, some armed men reached the city's market area, where two to three banks were damaged.

## CBI conducts raids at multiple locations in Kolkata in bank fraud case involving mining company

The CBI conducted raids at several locations in Kolkata in connection with a loan fraud case involving a mining company that allegedly caused a loss of Rs 7.25 crore to UCO Bank. Officials said raids were conducted at the residence of a businessman in the New Alipore area of the city and other locations, including New Town. They said five CBI teams conducted searches at a multi-storey residential complex on the fifth floor in the New Alipore area, in addition to New Town. According to media

reports, the complex is believed to be linked to Amit Kumar Kejriwal and Sarwan Kumar Kejriwal, promoters and guarantors of Swati Mining Company. An official said the coordinated operation was aimed at collecting documentary evidence and other materials related to the investigation. The CBI had registered a fresh case on December 30, 2025, against the company, its directors Girija Thakur and Samrat Chakraborty, and promoters and guarantors Amit Kumar Kejriwal and Sarwan Kumar Kejriwal, based on a complaint from UCO Bank.

Minister's Office, the Prime Minister will lay the foundation stone for several rail and road infrastructure projects worth Rs 3,250 crore in West Bengal on Saturday. He will virtually flag off a total of 7 Amrit Bharat Express trains from Bengal. These trains will connect cities like New Jalpaiguri, Alipurduar, and Malda with metropolitan cities like Bengaluru, Mumbai.

**Banka:** A review meeting of the Health Department was convened in the auditorium of the Banka Collectorate under the chairmanship of Banka District Magistrate Mr. Nav Shukla, IAS. The meeting was attended by Dr. Jitendra Kumar Singh, Civil Surgeon, Banka, Dr. Sunil Kumar Chaudhary, District Immunization Officer, Dr. Sohail Anjum, Communicable Diseases Officer, Dr. Vijay Kumar, Non-Communicable Diseases Officer, Brajesh Kumar Singh, District Program Manager, Amarendra Kumar Arya, District Accounts Manager, Mukesh Kumar, District Monitoring and



Evaluation Officer, Manish Lal, District Community Mobilizer, District Health Committee, Rajesh Kumar, District Monitoring and Evaluation Officer (DMHP), all Medical Officers In-Charge, Block Health Managers, Block Community Mobilizers, and other health workers. In the meeting, the District Magistrate of Banka issued the following directives: All Medical Officers In-Charge were directed to increase achievement in all indicators to meet the targets so that the district's ranking at the state level remains at least in the top 5. The achievement in institutional deliveries in all health institutions within the district was found to be unsatisfactory. A warning was issued to

increase the achievement to 75 percent of the target in the coming month, failing which the salaries of the concerned Medical Officer In-Charge and Block Health Manager/Hospital Manager will be withheld. During the review, taking serious note of the decline in institutional deliveries and cesarean sections at the Sadar Hospital, Banka, the Deputy Superintendent of Sadar Hospital, Banka

was directed to ensure that facilities for institutional deliveries and cesarean sections are provided to patients in a timely manner at night. All doctors were also directed to be present at their workplaces on time according to the roster and discharge their duties. In this regard, the Civil Surgeon, Banka, also assured that the facility for cesarean sections at night will be provided at Sadar Hospital, Banka in the

current month. During the review, all medical officers in charge were directed to ensure 100% completion of antenatal check-ups for pregnant women, including the first, second, and fourth ANC visits. To achieve this, they were instructed to conduct weekly meetings with ASHAs and ANMs, reviewing progress at each sub-center to ensure 100% achievement. All medical officers in

charge were directed to ensure that during the review of maternal and infant mortality, verbal autopsies are completed for all maternal deaths and the cause of death is investigated before reporting on the portal.

They were also instructed to ensure that ASHAs and ANMs in their respective areas conduct home visits for post-natal health check-ups of mothers and children, and to review this progress in weekly meetings. The availability of cesarean section facilities to pregnant women was found to be satisfactory at Sadar Hospital, Banka, Referral Hospital, Amarpur, Bounsi, and Community Health Center, Dhoraiya. Furthermore, not a single cesarean section

officers in charge have been directed to form teams at the block level to ensure inspection of VHSND sites. The district's achievement in hemoglobin check-ups and distribution of IFA tablets to pregnant women was found to be satisfactory. Under the future program, various indicators were reviewed, including online OPD consultations, vital signs taken, chief complaints, and prescription dispensing, which were discussed in detail. While reviewing the ongoing works under MNREGA, the Deputy Commissioner directed that work should be completed as per the target by providing employment to as many laborers as possible. Reviewing the progress of work at the selected sites

under the Poto Ho Sports Ground scheme, the Deputy Commissioner emphasized developing the sports grounds in a quality manner and encouraging sports activities for youth and children. During the review of the Birsa Well Promotion Scheme, the Deputy Commissioner directed that the pending wells be completed expeditiously, that farmers receive benefits on time, and that technical standards are followed. Under the Nutrition Garden scheme, special emphasis was placed on accelerating the establishment of

nutritious gardens in Anganwadi centers and rural households, and on improving the nutritional status of women and children. Reviewing the Manav Yojana (Rural) and Abua Awas Yojana, the Deputy Commissioner directed that

**Brief News****East Singhbhum: Mother Goddess Still Worshipped on 200-Foot-High Talai Hill**

**East Singhbhum:** Talai (Tilai) Hill, located on the border of Rajnagar-Potka block in East Singhbhum district, once again became a witness to faith, belief, and tradition, as the grand worship of Mother Thakurani was performed with full rituals on 'Akhan Din', the second day of the Makar Sankranti festival. This is not just a religious ritual, but a living picture of the faith that has been passed down through generations, behind which lies a true and inspiring story. From morning onwards, a devotional atmosphere prevailed in the surrounding villages, including Dangaradiha, Sijulta, Hensal, and Pata Hensal. Amidst the sound of drums and trumpets, devotees dressed in traditional attire, and chants of "Jai Maa Thakurani," the entire area seemed to be filled with divine energy. At the Thakurani temple in Hensal village, the first formal worship was performed by Naik Baba Bhim Sardar and Manindra Gop, son of village head Ashok Gop. After this, a group of devotees reached the Thakurani temple in Pata Hensal, where they collectively prayed to the Mother Goddess for happiness, peace, and prosperity. From here begins the most difficult but most sacred journey of faith. After the worship at the temple, all the devotees proceeded towards the summit of the approximately 200-foot-high Talai Hill. The uneven path, the height, and the fatigue—amidst all this, only faith kept the devotees going. Upon reaching the ancient well-like worship site at the top of the hill, the atmosphere became even more divine. It is believed that Mother Thakurani herself appeared here and bestowed blessings for the protection and welfare of the village. It is because of this belief, stemming from a true incident many years ago, that the tradition of this worship began, which the villagers continue to observe with complete devotion even today. **Drinking Water Scam Case: High Court Stays FIR Against ED Officials, Directs State Government to Provide Security**

**Ranchi:** Amidst the conflict between the Enforcement Directorate (ED) and the Jharkhand Police, the Jharkhand High Court has stayed the police action on the FIR filed by Santosh Kumar, an accused in the drinking water scam, against ED officials. The court also directed the state government to provide full security to the ED officials and their office. The case was heard on Friday in the court of Justice S.K. Dwivedi of the Jharkhand High Court. Hearing the writ petition filed by the ED, the court clarified that no punitive or investigative action would be taken against the ED officials for the time being. This order of the court has brought great relief to the ED officials against whom Santosh Kumar, an accused in the money laundering case, had filed a named FIR. Following the court's order, paramilitary force BSF will now be deployed for the security of the ED officials and their office. The court has also directed the state government and Santosh Kumar to file their replies in the matter. The next hearing of the case has been scheduled after two weeks. The Enforcement Directorate had filed a writ petition in the Jharkhand High Court against the action taken by the Ranchi Police at the ED office on Thursday. In the petition, the ED demanded that the FIR filed by Santosh Kumar be quashed and that the entire case be investigated by the Central Bureau of Investigation (CBI). The ED had also requested an early hearing in the matter. During today's hearing, the ED informed the court that important evidence related to the involvement of several senior officials has emerged during the investigation of the drinking water scam. The ED alleges that the FIR filed by Santosh Kumar is aimed at influencing and putting pressure on the investigation of the scam.

The hospital has introduced a scalp cooling therapy machine, which has been installed here for the first time in Bihar and Jharkhand. Dr. Gunjes Kumar of the hospital's Oncology Department explained that this machine is based on vasoconstriction technology. A continuous flow of coolant is maintained in a cap filled with the cooling agent. The machine's temperature is

approximately 0° Celsius, while the cap's temperature ranges from 17° Celsius to 21° Celsius. This cooling constricts the blood vessels, reducing the effect of

chemotherapy drugs on the hair follicles. Dr. Gunjes said that this technique controls hair loss in more than 50 percent of patients, which is considered highly effective globally. For cancer patients, especially women, losing hair is a psychological trauma. This technology empowers them physically as well as mentally and improves their quality of life. Dr. Nitesh Kumar, Facility Director of the hospital, said that Paras Hospital Ranchi is continuously working towards providing modern and advanced facilities for its patients, and this scalp cooling therapy machine is a part of that effort. This step by Paras Hospital has emerged as a new ray of hope for cancer patients.

**JDU Submits Memorandum to SSP (City) Regarding Kairav Gandhi's Kidnapping**

# 'As if it's Jantar Mantar!' SC 'disturbed' by ED's charge; agency says TMC asked people to come to HC before I-PAC raid hearing

**NEW DELHI, Agency:**

The Supreme Court on Thursday expressed that it was "disturbed" by the chaos at Calcutta high court on January 9 which led to the adjournment of the hearing on ED plea against Mamata Banerjee government over I-PAC raids. Reacting to the central agency's charge that TMC "instructed" people to go to the HC, SC remarked whether it was a protest site like Jantar Mantar.

"Kindly see what happened in this case. We approached the (Calcutta) High Court. This is what happens when mobocracy replaces democracy. This is what the high court records. I have placed on record Whatsapp chats of the

law wing of the party in power. This was not spontaneous and they were instructed by the legal cell of the party to go there," PTI quoted SG Tushar Mehta saying.

"Come everyone? As if it's Jantar Mantar!", remarked Justice Mishra. The SG pointed out that "buses and vehicles" had allegedly been arranged to ferry people to HC on January 9. He further said that prior to yesterday's hearing, the acting chief justice had issued an administrative order restricting the entry of unauthorised persons into the courtroom.

"The proceeding was live-streamed and the hearing was less than satisfactory. ED faced many difficulties and



the microphone was constantly muted," Mehta said.

As advocate Kapil Sibal commenced his submissions on behalf of Mamata, the

bench observed that the incidents that unfolded in the Calcutta HC were disturbing. "We are disturbed by the manner in which the hearing

in the High Court was last week adjourned due to commotion," Justice Mishra said.

When the SG suggested that the gathering in the courtroom may have been intentional or unintentional, the judge responded, "intentional or not, the high court has recorded something", pointing to the fact that the high court itself had adjourned the matter after recording the reason as commotion.

Calcutta HC proceedings were adjourned on January 9 after chaos disrupted the hearing in the ED-I-PAC matter and the Trinamool Congress's counter-petition.

The top court termed the ED's allegation that Mamata

obstructed its investigation as "very serious" and said it would examine whether state authorities can interfere with probes conducted by central agencies in serious cases. The court stayed the FIR filed by West Bengal police against ED officials and ordered that CCTV footage of the January 8 raids be preserved.

The ED approached the top court after its officers allegedly faced resistance during searches at the I-PAC office and the residence of its director, Pratik Jain, in a coal smuggling case. While the ED claimed Banerjee entered the premises and took away "key" evidence, the chief minister and the TMC denied it.

## Cash recovery row: Supreme Court junks Justice Yashwant Verma's plea; inquiry panel to proceed

**NEW DELHI, Agency:**

The Supreme Court on Friday dismissed Allahabad high court judge Yashwant Verma's plea challenging Lok Sabha speaker's decision to appoint a committee for his impeachment.

This comes after Verma moved the top court following Lok Sabha Speaker Om Birla's announced that a three-member panel has been constituted to investigate allegations against him. The members of the committee include Justice Amit Kumar, Justice Maninder Mohan Srivastava and B B Acharya, the Lok Sabha Speaker announced. Birla accepted the motion signed by 146 MPs for impeachment of Justice Yashwant Verma.

Earlier in August last



year, the top court held that an in-house inquiry procedure which led to a recommendation to remove Justice Yashwant Verma has legal sanction.

The apex court dismissed a plea filed by Justice Verma challenging the in-house inquiry panel's report, and the former Chief Justice of India (CJI) Sanjiv Khanna's recommendation

to initiate impeachment proceedings against him in the case of the fire incident that led to recovery of burnt unaccounted cash at his official residence in the national capital, when he was a sitting judge of the Delhi High Court.

Cash was allegedly found by fire tenders when a fire broke out at his Delhi residence on March 14, while

he was a judge of the Delhi high court. The judge was not present at his house.

During a hearing on July 28, the Apex court had posed various questions to Justice Yashwant Varma while hearing his plea. The court asked Senior Advocate Kapil Sibal, appearing on behalf of Justice Varma, why his client did not challenge the three-judge in-house inquiry procedure constituted by the Chief Justice of India prior to his appearance before the panel.

The top court questioned why Justice Varma chose to appear before the in-house inquiry panel if he believed it was unconstitutional, and why he is challenging it only now, after the proceedings have concluded.

## Chinese manja menace kills 9 in Gujarat, fireman in Maharashtra

**SURAT/BHIWANDI, Agency:**

The menace of banned Chinese manja cast a deadly shadow over the kite-flying season, killing nine people in Gujarat, while a fireman in Maharashtra and a 33-year-old man in Vadodara were electrocuted in kite-linked accidents.

In Surat, a motorbike carrying a couple and their daughter plunged about 60ft from Chandrashekhar Azad flyover. Sources said Rehan Shaikh, 34, lost control while trying to avoid manja strands dangling across the bridge and struck the railing, throwing all three down to the ground below. Shaikh and daughter Alisha Khutun died after being rushed to hospital. Shaikh's wife Rehana Bibi, who initially survived, died at hospital on Thursday.

Riyansh Borse, 8, was cycling in Surat's Jahangirpura when a



kite string cut his throat and he died bleeding. Prince Batham, 23, died in a similar way in another location. He was the youngest among three brothers and a native of Kannauj in UP.

In Bharuch district, Rahul Parmar, 35, died after a manja cut his throat while riding a motorcycle. An eight-year-old boy died after suffering critical neck injuries in Anand district while riding with his father on the motorcycle's fuel tank. In Aravalli district, 17-year-old Tirth Patel died after a kite string caught his neck.

## Omar Abdullah speaks to Jaishankar on J&K students stuck in Iran

Jammu and Kashmir chief minister Omar Abdullah spoke on Thursday with external affairs minister S. Jaishankar on the situation in Iran and cited assurances that all steps will be taken for the safety of hundreds of students and others from J&K stranded in the protest-wrecked country.



PDP president and former CM Mehbooba Mufti sought central intervention. "Thousands of students from across the country, including Kashmir, are stranded in Iran amid the present volatile situation. This has triggered deep fear and anxiety in anguished parents desperately worried about their children's safety. Urge S. Jaishankar and MEA (external affairs ministry) to intervene urgently and ensure their safe return," Mehbooba posted on X.

## Opposition slams Chhattisgarh govt as 'rat' theory blamed for vanishing paddy

**RAIPUR, Agency:**

'Rats' have become Chhattisgarh's newest political flashpoint after managers at paddy procurement centres blamed rodents, among other reasons, for paddy worth crores of rupees going missing or rotting.

In Kabirdham district, about 26,000 quintals of paddy worth Rs 7 crore were reported 'damaged', dried or missing from two procurement centres. Officials initially cited rats, termites, and weather as reasons for the loss, triggering a backlash from opposition parties which alleged a statewide scam in grain procurement and storage.

The state issued a clarification, stating that reduc-



tion in paddy weight due to moisture loss and minor pest-related damage is a scientific, natural and decades-old phenomenon, not evidence of corruption. Officials stressed that paddy loses weight when stored in open due to evaporation of moisture, a phys-

ical process recognised across all major paddy-producing states.

However, opposition parties alleged the 'rat' explanation was a cover for the scam as paddy worth Rs 30 crore across Kabirdham, Mahasamund, Jashpur, and Bastar has either rotted,

gone missing or been written off on account of pests, moisture, and weather.

Janta Congress Chhattisgarh launched a 'wanted rats' campaign in Kabirdham's Kawardha, putting up posters across district. The party's state chief, Amit Jogi alleged, "They are saying rats ate paddy. So, we have put up posters and are searching for this missing rat." He urged people to tell the party "whether these rats have four legs or two."

As the controversy grew, BJP MP Brijmohan Agrawal added fuel to the fire with a sarcastic remark that the govt would "arrange cats for the treatment of rats" accused of devouring paddy.

## Experts warn: Mass removal of stray dogs could backfire on public health

**NEW DELHI, Agency:** A coalition of multisectoral experts from a range of global institutions has lent its weight to petitioners in the stray dog case being heard in Supreme Court. The coalition warned that authorities' proposals to remove and mass-shelter India's free-living community dogs could undermine public health, go beyond the law, destabilise urban ecosystems and impose enormous fiscal costs, without delivering greater public safety.

The cautionary note draws on experience of veterans in public health, behavioural science, veterinary medicine and law. Signatories include Chinni Krishna who pioneered India's Animal Birth Control programme, evolutionary biologist Lee Dugatkin

(University of Louisville, US), Anindita Bhadra of IISER Kolkata, public health expert Leena Menghaney, Pushpinder Singh Khera of AIIMS Jodhpur, and Julie Corfmat of Mission Rabies among a host of others. Organisations include International Companion Animal Network (ICAN), Pet Dog Trainers of Europe (PDTE), International Institute for Canine Ethics (IICE) and Bangalore Hundeskole Academy for Research and Canine Studies (BHARCS). Highlights of their analysis:

Free-living dogs form stable social groups when food sources, sterilisation, and vaccination coverage remain consistent.

Large-scale removal disrupts these



systems, creating territorial vacuums that are rapidly filled by other dogs -- often unvaccinated and unsterilised -- an effect associated with increased dog-bite incidents and heightened disease risk.

Mass removal undermines rabies control by dismantling herd immunity. India's existing Catch-Neuter-Vaccinate-Release (CNVR) frame-

work, when implemented consistently, targets the internationally recognised threshold of vaccinating at least 70% of dogs in a given area. Data show steep declines in human rabies deaths and dog-bite incidence in areas with sustained sterilisation and vaccination programmes. Abandoning this approach risks reversing hard-earned gains achieved over past two decades. Mass sheltering, experts argue, compounds the risks. High-density animal housing is globally classified as a biohazard activity, requiring stringent quarantine, disease surveillance, and worker-safety protocols. Dugatkin noted claims justifying removal often rest on myths rather than biology. "These dogs have coexisted with humans in India for millen-

nia. Disrupting stable populations based on fear or misinformation ignores everything we know about animal behaviour and disease ecology," he said. Anthrozoologist Sindhu Pangal said the debate had become detached from evidence. "Replacing proven, low-cost public-health systems with a mass-detention model is not just unscientific -- it actively increases risk while draining resources that should be strengthening vaccination and disease prevention," she said. Position statements from IICE highlight that large shelters frequently experience overcrowding, stress-induced immunosuppression, and rapid disease transmission, particularly where enforcement capacity is limited.

**EDITORIAL****Diluting ISI's institutional autonomy**


The 95-year-old Indian Statistical Institute (ISI), considered the gold standard for statistical research in the country, is facing the threat of losing its institutional autonomy and independence following the NDA government's move to revamp its structure and convert it into a corporate body. This fits into a broader pattern of systematic dilution of institutional autonomy and federal values through over-centralisation of powers over the last few years. The Draft Indian Statistical Institute (ISI) Bill, 2025, released by the Ministry of Statistics and Programme Implementation (MoSPI), proposes major structural reforms that appear to be opaque and hastily formulated without any prior debate. The Centre wants to overhaul the governance structure of the Kolkata-based premier institute, which is synonymous with India's early efforts to use Statistics for policy and development. There are growing concerns over how the hasty reforms could dilute the autonomy and undermine the federal spirit. Over 1,500 academicians have expressed grave concern and held demonstrations to protest the government's plan, which focuses on corporatisation and revenue generation. What is alarming is that the draft Bill, seeking to repeal the Indian Statistical Institute (ISI) Act, 1959, omits references to national development, social welfare, and planning but introduces new priorities such as global excellence, interdisciplinary collaboration, innovation, and financial self-sustainability. Experts fear that increased focus on revenue generation may shift ISI away from basic research, and the essential long-term research could suffer under a corporate-style funding model. The new legislation undermines the original agreement under which the ISI society was formed in 1931. The institution's historical contributions include the development of the National Sample Survey Organisation (NSSO), which laid the foundation for India's official statistical system. The proposed Bill seeks to transform ISI from a registered society into a statutory body. This structural shift is framed by the government as a step toward modernising and strengthening ISI as it approaches its centenary. Under the 1959 Act, ISI's governance rested with a council that included significant academic representation, including 10 members from within ISI. The draft Bill's new Board of Governance (BoG) is heavily dominated by government nominees, leaving no elected representatives from among faculty or researchers. This raises concerns of political interference, especially in appointments and academic decision-making. The proposed BoG is empowered to make key administrative and academic decisions. It also has provisions to significantly expand revenue generation through student fees, consultancy services, and sponsored research projects. Centralised control is proposed over faculty selection, recruitment, and appointments. The focus of the new legislation shifts from a nation-building and welfare-oriented mission to one centred on global excellence, institutional branding, and innovation. Bypassing the existing society registered under state law amounts to an infringement of state jurisdiction and risks undermining the established legal framework that has guided ISI for decades. The Bill severely undermines academic autonomy by enabling the BoG to override decisions of the Academic Council.

**Economists see India's GDP growth strong in real terms**

The National Statistics Office (NSO) on Wednesday released the first advance estimates estimating the Real GDP to grow by 7.4% in the Financial year 2025-26 against the growth rate of 6.5% during FY 2024-25. Real GDP is estimated to attain a level of Rs 201.90 lakh crore in FY26, against the Provisional Estimates (PE) of GDP for FY25 of Rs 187.97 lakh crore, it said. Further, the data said the Nominal GDP is estimated to grow at 8% in FY2025-26.

Speaking on the estimates, Dharmakirti Joshi, Chief Economist, Crisil said, "The 60 basis point gap between nominal and real GDP this fiscal will be the lowest since 2011-12." India's growth momentum has sustained despite elevated global uncertainty due to tariff tensions, riding on accommodative monetary and fiscal policies, robust corporate balance sheets, and favourable developments such as above-normal monsoons and low crude oil prices.

Fixed investments is the primary driver this fiscal, with growth picking up to 7.8% vs 7.1%. Private consumption growth has held up at 7% -- above the trend but a tad slower than the previous fiscal," he said. "Next fiscal, we expect the nominal and real growth to flip -- nominal growth is expected to rise to close to its long-term average at 10.5-11% and real growth to be at 6.7%," he added. "While the scope for further policy rate cuts will be limited, transmission of previously announced cuts will continue to



support the economy next fiscal. The effects of monetary policy typically operate with a lag. We expect the government to maintain capital expenditure growth at a moderate pace in the forthcoming budget."

"Of late, the government has been advancing domestic reforms, including deregulation, to improve the business climate and enhance the economy's long-term growth potential. These measures could have a positive impact on private investments, which are beginning to show some signs of improvement," Joshi said. DK

Srivastava, Chief Policy Advisor, EY India said First Advance Estimates for 2025-26 indicate a narrowing of the difference between nominal and real GDP growth rates which are estimated at 8.0% and 7.4% respectively.

Real growth remains fairly impressive. "This growth is clearly led by growth in investment of 7.8% which exceeds private final consumption expenditure growth of 7%. On the output side, services growth with its three main segments of trade, transport et al., financial and real estate, and public administration,

growing at 7.5%, 9.9% and 9.9% respectively, thereby outperforming the growth of manufacturing which remain healthy at 7.0%. Agricultural growth at 3.1% is lower than the average of the last four years which is 4.5%," Srivastava said. "The unexpectedly low implicit price deflator-based inflation at 0.5%, leading to a nominal GDP growth of 8% has significant implications for the revised estimates of the 2025-26 budget aggregates.

In particular, the budget estimates for this year had

assumed a nominal GDP growth of 10.1%. Although this does not affect the magnitude of fiscal deficit which at 4.4% of nominal GDP was budgeted at Rs 15.7 lakh crore. "Dr. Manoranjan Sharma, Chief Economist, Infomerics Ratings said, "This momentum is underpinned by several structural drivers: sustained public capital expenditure across infrastructure, transport, and energy; resilient domestic consumption, particularly in urban markets; an improving investment cycle supported by corporate deleveraging; continued strength in services—notably IT, finance, and tourism; and overall macroeconomic stability, reflected in contained inflation and a manageable fiscal deficit."

While these forces are tangible, their durability and alignment cannot be taken for granted. "Growth remains supported by public investment-led expansion, the continued dominance of the services sector, and India's favourable demographics combined with a large domestic market, which together provide resilience to demand and output," he said. However, risks persist from elevated global economic uncertainty, still-cautious private investment sentiment, vulnerability in agriculture due to weather dependence, and potential inflationary pressures that could limit monetary policy flexibility, he highlighted.

**US withdraws from 66 international organisations**

US President Donald Trump signed a memorandum on Wednesday (local time), directing the withdrawal of the United States from international organisations, conventions and treaties that are "contrary to the interests" of the US. The announcement was made in the statement of the Presidential

International Union for Conservation of Nature (IUCN) and the Intergovernmental Panel on Climate Change. Other non-UN bodies International Energy Forum, the International Renewable Energy Agency, the Partnership for Atlantic Cooperation and the Global Counterterrorism Forum, among others. Key UN organisations from

executive departments and agencies to take immediate steps to effectuate the withdrawal of the United States from the organisations mentioned in the memorandum as soon as possible, and said that for United Nations entities, withdrawal would mean ceasing participation in or funding to those entities to the extent permitted by law. It mentioned that Trump's decision comes after considering the Secretary of State's report and after deliberating with his Cabinet, that he determined the participation, or support to the organisations was contrary to the interests of the United States.

The move almost a year after the Trump administration had announced the withdrawal from the

World Health Organisation (WHO) in January 2025, citing the mismanagement of the COVID-19 pandemic. The US had also withdrawn from UNESCO in July 2025, saying that the latter was not in the "national interest" of the United States.

That call seemed distant until a proposal arrived from a reputed family in Tarn Taran. Coincidentally, my younger brother was already engaged to

a girl from the same town, with their wedding set for the following April. Though the alliance appeared convenient yet a strange reluctance lingered within me. I did not wish to have my in-laws settled in the same town as my brother's. "I will meet her when we visit Tarn Taran for my brother's wedding," I told the family, more to buy time than out of interest. My heart whispered a silent 'No'.

April arrived in a whirlwind of colour, music, and vibrant Punjabi wedding celebrations. The moment which I had been postponing finally arrived. My eldest

sister and I were ushered into their drawing room. I had already rehearsed my polite refusals in my head. But the moment the girl entered the room, the world shifted. All my 'Nos', refusals and rejections crumbled in an instant.

She was incredibly beautiful and I felt drawn to her immediately. It was as if chorus of bells had rung in my heart, signalling that this was it. The sound of those bells was like a symphony, telling me that we had met for a reason. The room fell silent for a moment. As if the slightest sound might shatter the spell she had cast. She

moved towards the chair opposite me, her eyes briefly meeting mine before lowering, a soft blush colouring her cheeks. Her mother followed behind with a tray, yet the clatter of teacups felt miles away. My sister nudged me gently—a silent reminder to speak.

"What are your plans after completing your studies?" I finally managed. "Do you intend to enter service?" She looked up, "I have no such plans as of now," she replied in her soft voice which matched the sound of bells which I had just heard.

There was subtle wit in her eyes, a spark of

intelligence that complemented her beauty. As she served the snacks, I watched her hands and the grace of her movements, suggesting a deep-seated composure. It was a slow, soulful tune from an old movie 'Sangam'. My colleagues would playfully dance to the music, but I stayed still, anchored by the melody, drifting to a place where she was the only thing in focus.

The daily drills and lectures became nothing more than a distant hum. My mind was a battlefield of emotions as I replayed our meeting over and over, overanalyzing every word and every glance. The weapon training was tough, but it was nothing compared to

the ache in my heart. I was simply counting the days until I could see her again, hold her hand, and finally tell her how I felt.

Years later, the girl from Tarn Taran is no longer a fleeting vision. She is the anchor of my life—my beloved wife. The one who once occupied every corner of my thoughts during those lonely training days now moves gracefully through our home, surrounded by our children and grandchildren.

The bells that rang in my heart that day still chime softly—a constant reminder of made-to-meet meeting.

## World Bank approves \$286 million loan to improve quality healthcare in Bengal

**New Delhi, Agency:** The World Bank has approved financing for a program to improve the quality of life and life expectancy in West Bengal through wider, more equitable access to quality healthcare.


The West Bengal Health System Reform Program Operation, with a USD 286 million loan, will support the delivery of personalised healthcare services across the state for people aged 30 and above through digital tracking of non-communicable diseases (NCDs) such as hypertension and diabetes.

It will also bring a patient-centric care approach to the state's health systems, improve health outcome measurement, and enhance healthcare facilities' resilience to extreme

weather events.

The Program will also support strengthening gender-based violence (GBV) services, including targeted interventions for boys, married adolescents, and healthcare providers. In the five districts of Purulia, Birbhum, Murshidabad, Maldah and Uttar Dinajpur, the Program will improve access to quality healthcare services and reduce inequities in maternal and adolescent health.

The World Bank said West Bengal has made sustained health gains in the past two decades with infant mortality rates declining from 32 deaths per 1,000 live births in 2010-2012 to 19 in 2018-2020. The total fertility rate was 1.64



births per woman in 2019, among the lowest in the country.

As a result, life expectancy in West Bengal is 72 years, which is higher than the national average. However, in spite of these gains and high literacy rates among adolescent girls (at 89 per cent), West Bengal has the second-highest rate of adolescent pregnancies in India at 16 per cent, which also drives the maternal mortality ratio at 103 deaths per 100,000 live births in 2018-2020. The districts of Purulia, Birbhum, Murshidabad, Maldah and

Uttar Dinajpur face critical challenges in reproductive, maternal, and adolescent care.

"This Program will help West Bengal deliver more equitable and higher-quality health services, with measurable results for women, adolescents, and people living with non-communicable diseases," said Paul Proce, the World Bank's Acting Country Director for India.

"By linking financing to verified outcomes and strengthening governance and climate resilience, the operation addresses both service gaps and systemic constraints that have held back health gains for vulnerable communities. This will have a direct impact on the ability to seek good jobs."

"Strengthening the continuum of care at the primary level through measures like control of hypertension and diabetes is central to bending the NCD curve," said Rahul Pandey and Meghna Sharma, the Task Team Leaders of the program.

"The program's focus on quality-of-care interventions and mechanisms to respond to gender-based violence are vital to improving health outcomes and trust in the healthcare system."

The USD 286 million loan from the International Bank for Reconstruction and Development (IBRD) has a final maturity of 16.5 years, including a three-year grace period.



## Copa del Rey: Barcelona reach quarterfinals after beating Racing Santander 2-0

**Cantabria, Agency:** Barcelona put on a superb performance in the Copa del Rey, defeating second-division top team Racing Santander 2-0 on Thursday and securing a place in the quarterfinals. Alianza Lima Femenino said in its statement, "Alianza Lima women's team announces the signing of Indian midfielder Manisha Kalyan. She will strengthen the team's attack. Manisha has joined from Greek club PAOK FC, where she competed at the highest level of European football."

Alianza Lima Femenino will be the third foreign club in Manisha Kalyan's career. After playing for Sethu FC and Gokulam Kerala FC in India, Manisha joined Cypriot club Apollon Ladies FC in 2022. ## Ghulam Mustafa Khan: How a classical singer carved the sounds of Bollywood


Born on 3 March 1931 in Badaun, Uttar Pradesh, Ghulam Mustafa Khan was destined for music even before his birth. His father Ustad Waris Hussain Khan and grandfather Inayat Hussain Khan (founder of the Rampur-Sahaswan Gharana) had decided that this child would carry forward the Caliphate tradition of the house. Ustad often recalled that while other children played marbles in the streets, he used to practice kharaj (low octave) for hours in front of his father. His father was very strict in matters of music. Once Ustad had told, "My father loved me very much, but whenever I used to sit for Riyaz, he used to discipline me like a soldier. It was this discipline that created the preparation in his neck, which later on would run for three and a half octaves without getting tired. Ustad Ghulam Mustafa


